- 4. Candidates will have to fill the preferences as per their priority of Institute/Institutes and Course/Courses. There is no restriction on the number of preferences to be filled in. They are advised to fill as many preferences as possible for Institute/Institutes and Course in which they are interested to take admission, for securing seat allotment.
- 5. Candidates who have been recommended for admission, will have to submit all concerned original certificates/documents as per their seat allotment failing which their Provisional Seat Allotment Letter will be deemed cancelled.
- Candidates who are admitted on the basis of previous round of online Counselling and want to change branch and/or institute against the remaining vacant seats can appear in this Counselling. If the seat is re-allocated in this Counselling, it will be mandatory for the candidate to get admitted in the newly allotted branch and/or institute as their earlier

admission will automatically be cancelled and the seat thus vacated will be allotted to another candidate on merit-cum-choice basis by the Board.
