**Important Information Regarding First Round of Counselling on 04.04.2019  
the basis of State Merit List of PG Medical– 2019/ PG MDS– 2019 for State  
Quota seats.**

1. All eligible eager Candidates will have to be **physically present** on 04.04.2019 at 10.30 AM and must produce following certificates/documents in **ORIGINAL** at the time of counselling as applicable in their cases:-
  - a). Admit Card of NEET-P.G. – 2019/NEET MDS-2019.
  - b). Certificate of passing matriculation or equivalent.
  - c). Registration Certificate granted by the Bihar/Jharkhand State Medical Council/Medical Council of India.
  - d). Marks Sheet of each MBBS /BDS Examination including those of failure(s) if any.
  - e). Attempt certificate indicating numbers of failures at each MBBS/BDS Examination.
  - f). PAN card/Driving license/Voter card/Passport/Aadhaar card.
  - g). In case of claiming reserve category seat, Caste Certificate as per format given on the home page of the Board's website under Downloads column is required and it must be issued by C.O./D.C./S.D.O. (Civil) of the State of Jharkhand. The caste certificate issued by any other authority will not be considered for claim of reservation and his/her claim for reservation will be refused and he/she will be treated as General category candidate [Format of Caste certificate is available in ACT & circular/Download column of Board's Website]. As per Memo no. 1754 dated 25.02.2019 of Department of Administrative, Personnel Reforms and Rajbhasha, GoJ, candidates belonging to BC – I & BC – II, have to submit/show the Caste certificate which includes **a certificates of Creamy Layer factor** also at the time of counselling. **Caste certificate produced by BC – I & BC – II candidates will be valid only if he/she does not belong to creamy layer & it must have mention in CASTE CERTIFICATE.**
  - h). Local Residential Certificate issued by D.C./S.D.O. (Civil) of the State of Jharkhand [Format of LRC is available in ACT & circular column of Board's Website .
  - i). Certificate of completing Rotatory Internship.
  - j). Two passport size self attested photographs. Candidates who are studying in any Medical college, have to produce Bonafide Certificate at the time of counselling from the competent

authority in which it must be clearly mentioned that original Certificates/Documents have been retained by the Institute.

- k). At the time of admission, the candidates who are in service have to produce “No Objection Certificate” from their employer.
- l). Candidates who have claimed for incentive/reserved seat for serving in rural area have to produce up to date (Recent) certificate from concerned controlling officer that he/she is continuing in State Govt. Job and is currently serving/Previously serve in Rural Area (outside the jurisdiction of Municipal Corporation/Municipal Board/Town Panchayat)

**Note: A candidate failing to produce required Certificates/Documents at the time of counselling will not be given time to produce the same and will loose his/her Rank.** However, if he/she produces requisite Certificates/Documents during counselling session later on, he/she shall have the option of selecting only the Subject/Institute vacant at the time of submitting such Certificate/Document and no claim of his/her earlier (Original) merit position/roaster will be entertained.

- 7. Candidates being called to appear in the counselling are more in number than available vacant seats. Hence, call for counselling does not guarantee admission at all.**
- 8. Each eligible candidate will be allowed to exercise his/her option for Subject/Institute from available seats according to their merit position/roaster. **The counselling will be held as per total available seats and the 1-50 roaster point as notified** by the Govt. of Jharkhand.
- 9. Candidate has to pay **Counselling Fee**, through Challan/Demand Draft payable in favour of **"The Controller of Examination, J.C.E.C.E. Board" at Ranchi** to appear in the counselling. Counselling fee for Gen/EWS/BC – I/BC – II category candidate is ₹ 1,250/- and ₹ 1,000/- in case of SC/ST category candidate. Without paying the Counselling fee, the candidates can't participate in the Counselling procedure and he/she will forfeit his/her claim for allotment of PG seat against State Quota.
- 10. Candidate should note that once the Subject/Institute is opted at the time of his/her current running counselling, no subsequent request for change of Subject/Institute will be entertained for the current running counselling.**
- 11. The counselling will be held at the office of **Jharkhand Combined Entrance Competitive Examination Board, Science & Technology Campus, Sirkha Toli, Namkum-Tupudana Road, Namkum, Ranchi – 834010.**

12. In case of any dispute, the decision of the Controller of Examination, Jharkhand Combined Entrance Competitive Examination Board shall be final and binding.
