#### Submission of Online Application Form for Preparation of State Merit Rank on the basis of NEET(UG)-2019 Result

#### PRESS COMMUNIQUE

Online Application Forms are invited for preparing the State Merit Rank for conducting the Counselling for admission in MBBS/BDS/Ayush UG level courses from candidates who have qualified in NEET (UG) – 2019 & opted Jharkhand as State of eligibility besides fulfilling the following eligibility criteria:-

- a) **Residential Criteria:** The Candidate must be a citizen of India and Local/Permanent resident of Jharkhand. The "Local Resident of Jharkhand" has been defined & identified in 7/Aa. Niti (Sarvdaliaye Baithak) 27/2002 (Khand)ka.-3198/, dated 18.04.2016 of Personnel, Administrative Reforms and Rajbhasa Department, Govt. of Jharkhand. The Notification copy is available under Downloads column on website.  
A Candidate will have to submit Local Resident Certificate in proper format in ORIGINAL at the time of Counselling, issued by competent authority [Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State] along with the confirmation page of the Application Form filled by the candidate during online submission of application form of NEET(UG)-2019. The Residential Certificate issued by any other authority will not be entertained and his/her claim will be rejected. The Local Resident certificate format is available under Act & Circulars column on website. The candidates have to submit the Rank Card as well as confirmation page regarding eligibility of State.
- b) **Reservation on Caste Basis:** The current reservation policy of Govt. of Jharkhand will be followed for admission in all courses at Govt. and Non-Govt. Institutes. Candidates claiming reservation will have to submit Caste certificate in proper format in ORIGINAL at the time of Counselling, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The caste certificate issued by any other authority will not be entertained for claiming reservation and his/her claim for reservation will be rejected and the candidate will be deemed to belong to General category [Ref. Letter No.- 7/Aa.Ni. – 018-10/2003 ka- 7072 dated 30-12-2003 of "Personnel, Administrative Reforms and Rajbhasa Department," Govt. of Jharkhand]. As per Letter no. 14/Ja.Ni.-03-13/2015/Ka.-1754 dated 25.02.2019 of Deptt. Of Personnel, Administrative Reforms and Rajbhasa, Govt. of Jharkhand, Candidates belonging to BC – I & BC – II, have to submit/show the Caste certificate which includes Creamy Layer factor at the time of counselling. Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate. The Notification copy & caste certificate format is available under Act & Circulars column on website.
- c) **Reservation for Person with Disabilities:** As per Memorandum (Letter No. 2249 dated 03.04.2018) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi. The concerned Memorandum is uploaded on the Board's official Website.
- d) **Reservation for Primitive Tribal Groups Candidates :-** As per Memorandum (Letter No. 5555 dated 28.06.2016) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi. The concerned Memorandum is uploaded on the Board's official Website
- e) Interested eligible candidates are requested to fill the **Application Form Online** from 26.06.2019 to 01.07.2019 on Board's official website <http://jceceb.jharkhand.gov.in> by Clicking on "Click here for All Online Application Submission – JCECEB 2019" tab by following the given directions.
