Online Application Forms are invited for preparing the State Merit List for conducting the Counselling for admission in different branches of B.E./B.Tech. course of Engineering Institutes of Jharkhand State (List of Engineering Institutes for academic year-2020-21 is uploaded on the Board's website) from candidates who have been ranked in JEE (Main) – 2020 & fulfilling the following eligibility criteria:-

- 1. Educational Criteria:- The Candidate must have passed 10+2 examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry/Biotechnology/Biology/ Technical Vocational subject/Computer Science/ Information Technology/Informatics Practices/ Agriculture/ Engineering Graphics/ Business Studies & obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in the above subjects taken together (As per AICTE Approval Process HandBook 2020-21).
- 2. Residential Criteria:- The Candidate must be a citizen of India and Local/Permanent resident of Jharkhand. The "Local Resident of Jharkhand" has been defined & identified in 7/Aa. Niti (Sarvdaliaye Baithak) 27/2002 (Khand)ka.-3198/, dated 18.04.2016 of Personnel, Administrative Reforms and Rajbhasa Department, Govt. of Jharkhand. The Notification copy is available under **Downloads** column on the Board's website.

A candidate will have to upload Local Resident Certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The Residential Certificate issued by any other authority and in other than prescribed format will not be entertained and his/her claim will be rejected. The Local Resident certificate format is available under Act & Circulars column on Board's website.

3.(a) Reservation on Caste Basis:- The current reservation policy of Govt. of Jharkhand will be followed for admission in Institutes. Candidates claiming reservation will have to upload caste certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The caste certificate issued by any other authority and in other than prescribed format will not be entertained for claiming reservation and his/her claim for reservation will be

rejected.

As per Letter no. 14/Ja.Ni.-03-13/2015/Ka.-1754 dated 25.02.2019 of Deptt. Of Personnel, Administrative Reforms and Rajbhasha, Govt. of Jharkhand, Candidates belonging to BC – I & BC – II, will have to upload the caste certificate. Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate. The Notification copy & caste certificate format is available under Act & Circulars column on the Board's website.

(b) Reservation for Economically Weaker Sections (EWS):- Candidates from Economically Weaker Sections can avail benefits of reservation as per Memorandum (Memo No.-14/Aa.Ni.-04-02/2019/Ka.-1434 Dated 15-02-2019) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Candidates claiming reservation will have to upload Income & Assets Certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The concerned Memorandum and format for the Certificate is uploaded on the Board's Website.

(c) Reservation for Person with Disabilities:- Divyang candidates can avail benefits of reservation as per Memorandum (Letter No. 2249 Dated 03.04.2018) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Candidates claiming reservation will have to upload Disability Certificate in proper format, issued by competent authority [Chairman of the Medical Board & Countersigned by Medical Superintendent/Chief Medical Officer/ Head of the Hospital of Jharkhand State]. The concerned Memorandum and format of the Certificate is uploaded on the Board's Website.

- (d) Reservation for Service Man Quota (SMQ):- :- Candidates claiming reservation of SMQ will have to upload Dependency Certificate issued by Competent Army Personnel for Serving Personnel / Dependency Certificate issued by Zila Sainik Kalyan Board for discharged Personnel/ Discharge Book/Pension Book / Certificate as per their preference code.
- (e) Reservation for Primitive Tribal Groups Candidates: Candidates from primitive tribal groups can avail benefits of reservation as per Memorandum (Letter No. 5555 Dated 28.06.2016) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi. The concerned Memorandum is uploaded on the Board's Website.
- (f) <u>Tuition Fee Waiver Scheme:</u> As per AICTE, New Delhi, 5% Supernumerary seats are available for candidates in each branch. For this they have to upload Income Certificate of upto Rs. 8 lacs, issued by Circle Officer or Sub Divisional Officer (Civil) or Dy. Commissioner of Jharkhand State.

While filling up the online application form, the eligible candidates from reserved Category/Quota should claim benefits of reservation and/or scheme only when they already possess the concerned certificate issued in the proper format by the competent authority.
