**Notice regarding Counselling for POST-GRADUATE MEDICAL/DENTAL State Quota seats
on the basis of NEET-PG/NEET MDS-2019 Result**

Applications in prescribed format are being invited for the proposed counselling from NEET PG – 2019/ NEET MDS - 2019 qualified eligible candidates who fulfill the following eligibility criteria:-

- a) The candidates must have passed MBBS/BDS Examination from any University/Medical College of Jharkhand State.

Or

Those candidates who are resident of Jharkhand, admitted in MBBS/BDS course in the Medical colleges of Bihar in the session started from 2000/creation of Jharkhand State or admitted in Medical colleges of Bihar before the creation of Jharkhand State and have passed MBBS, may also apply as per Govt. of Jharkhand notification no. 9/vividh-13-05/2012 65 (9), Health/Ranchi, dated 07.05.2013. (They have to produce Local/Permanent residential certificate issued by D.C./ S.D.O. (Civil) of Jharkhand State).

- b) The candidates must have completed the Rotating Internship or likely to complete by 31 March, 2019.

Reservation:- Up-to-date Reservation Policies/Rules of the Govt. of Jharkhand will be applicable.

Certificate issued by anyone other than Circle Officer/Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State shall not be entertained and will lead to rejection of his/her claim. No other document in support of his/her claims for caste will be entertained. Caste certificate produced by BC – I & BC – II candidates claiming reservation in their category will be accepted only if he/she does not belong to creamy layer & it should be mentioned clearly in their caste certificates. The caste certificate format is available under Downloads column of the Board's official website.



If any candidate has any objections against his/her merit position, he/she will have to file representation in office of under signed with supporting paper/papers by 30.03.2019 at 4.00 PM, failing which his/her claim/merit will not be entertained at the time of counselling.

Final State merit list will be published on 02.04.2019 and on the basis of final state merit list, 1st counselling for state quota (PG medical & Dental) seats will be held on 04.04.2019 from 10.00 AM sharply.
