Online Applications are invited from qualified eligible candidates of NEET PG – 2020/NEET MDS - 2020 examination for the preparation of state merit list for conducting the 2<sup>nd</sup> Round of counselling for admission in Post-Graduate level Medical/Dental courses of state quota Vacant seats.

Interested eligible candidates are requested to fill the **Application Form Online** from **29.06.2020 to 06.07.2020** on Board's official website <http://jceceb.jharkhand.gov.in> by Clicking on " **POST-GRADUATE MEDICAL/DENTAL Online Application Submission – 2020**" tab by following the given directions.

**The Candidates already enlisted in State merit list of 1<sup>st</sup> Round Counselling need not have to apply again.** Eligibility criteria are same as per Advt. No. – JCECEB/04/20- 20 dated 19.03.2020.

As per Notice No. – U-12021/44/2019/54-MEC dated 23.06.2020, Directorate General of Health Services, Government of India, the Candidates holding PG Course (Degree/Diploma and MDS) seat in round -2 of All India Quota/Deemed University are not eligible to participate in any other Counselling.

Provisional State merit list for 2<sup>nd</sup> round of counselling will be published on **08.07.2020**. If any candidate has any objections against his/her merit position, he/she will have to file representation in office of under signed by e-mail [controller.jceceb@gmail.com](mailto:controller.jceceb@gmail.com) with supporting paper/papers by **10.07.2020 up to 4.00 PM**, failing which his/her claim/merit will not be entertained at the time of counselling.
