#### PRESS COMMUNIQUE

Online applications are invited from candidates having qualified in JEE (Main)-2022, for appearing in the Second Round of Online Counselling. The interested candidates should not have been included in the state merit list prepared earlier by the Board and they should be willing to enroll on the seats left vacant in different branches under B.E./B.Tech. course after the First Round of Online Counselling and fulfill the conditions contained in the advertisement no.-JCECEB./28/22 -59 issued by the Board on 12.09.2022.

2. Candidates recommended from the first round of Online Counselling and admitted in Engineering institutes, can also appear in the Second Round of Online Counselling for re-allotment of their institute and/ or course. If seat is allotted in the second round of Online Counselling, then it will be mandatory for them to take admission in newly allotted institute/branch and his/her previous admission will be automatically stand cancelled.

3. The candidates included in the state merit list issued by the Board on 24.09.2022 for the First Round of Online Counselling need not fill the online application form again.


