### Important information related to conduct of 3<sup>rd</sup> & 4<sup>th</sup> round of Online Counselling for admission to B.E./B.Tech. Course

#### PRESS COMMUNIQUE

In pursuance of letter no. - V.Pra.Chha.Na.-01/14 (Part-1)-948 dated 02.11.2022 of Higher and Technical Education Department, Ranchi, the Board is going to organize 3<sup>rd</sup> & 4<sup>th</sup> round of Online Counselling for vacancies in arising out of either non-allotment of seats or non-admission after the earlier counselling process for different branches under B.E./B.Tech. course.

2. Candidates recommended from the First and Second round of Online Counselling and admitted in Engineering institutes, can also appear in this Counselling for re-allotment of their institute and/ or course. If seat is allotted in the 3<sup>rd</sup> and/or 4<sup>th</sup> round of Online Counselling, then it will be mandatory for them to take admission in newly allotted institute/branch and his/her previous admission will be automatically stand cancelled.

3. There will be no registration for new Candidates for inclusion in the State Merit List. The candidates already included in the state merit list issued by the Board on 17.10.2022 for the Second Round of Online Counselling are eligible for this counselling.

4. The Interested Candidates willing to enroll on the seats vacant in different branches under B.E./B.Tech. course and concerned Engg. Institutes are hereby informed that the 3<sup>rd</sup> & 4<sup>th</sup> round of online Counselling will be conducted as per the following schedule :-

Candidates are advised to fill as many choices as possible for allotment of seats. **The candidates will fill in choices only once for the 3<sup>rd</sup> round of online counselling. They will be automatically upgraded for the 4<sup>th</sup> round of counselling as per existing vacancies.**
