In pursuance of schedule of Online Counselling hosted on the website of Ayush Admissions Central Counselling Committee (AACCC) on 20.01.2023, online applications are invited from candidates having qualified in NEET (UG)- 2022, for appearing in the Last Round of Online Counselling for admission in B.H.M.S. Course. The interested candidates should not have been included in the State Merit List prepared earlier by the Board and they should be willing to enroll on the seats left vacant in B.H.M.S. Course and must fulfill the conditions contained in the advertisement no.-JCECEB₀/61/22-72 issued by the Board on 06.10.2022 which can be seen under "Important Notice" Column of Board's website.

- 2. Interested eligible candidates are requested to fill in the Application Form Online from 03.02.2023 to 05.02.2023 on Board's website http://jceceb.jharkhand.gov.in by Clicking on " Click Here for All Online Application Submission JCECEB 2022" tab by following the given directions.
- 3. The Counselling will be held as per the Notice issued by M.C.C. of D.G.H.S. under Ministry of Health & Family Welfare, Govt. of India, New Delhi vide Ref. U- 12021/01/2022-MEC dated-12.07.2022. This Notice can be seen under "Download" Column of Board's website. Further Candidates admitted through any Round of AIQ or State Quota shall not be eligible for participating in this Counselling.
- 4. The candidates included in the State Merit List issued by the Board on 02.01.2023 for the 2nd Mop-up Round of Online Counselling need not fill the online application form again.
